1 On June 2, 2023 at 10:00 a.m., Plaintiffs William Muller, Antonio Knezevich, Adam Bente,
2 and Cindy Villanueva (“Plaintiffs”) Motion for Preliminary Approval of Class Action Settlement
3 (the “Motion”) came on hearing before the Court. The Court has considered Plaintiffs’ Motion, the
4 Class Action Settlement Agreement and Release between the Plaintiffs and Defendant UKG, Inc.
5 (“Defendant” or “UKG”) (collectively the “Parties”) (the “Settlement” or “Settlement Agreement”),
6 the proposed Class Notice, all declarations and other evidence submitted in support of the Motion,
7 and any argument submitted at the hearing on the Motion, and hereby finds and orders as follows:

8 1. Unless defined herein, all terms in this Order shall have the respective meanings ascribed
9 to them in the Settlement Agreement.

10 2. The proposed settlement set forth in the Settlement Agreement (the "Settlement") is hereby
11 preliminarily approved as being fair, reasonable, and adequate such that notice of the settlement
12 should be given to members of the Class.

13 3. The Court preliminarily finds that the Settlement, on the terms and conditions set forth in
14 the Settlement Agreement, is in all respects fundamentally fair, reasonable, adequate, and in the best
15 interest of the Class Members, when considering, in their totality, and to the extent such information
16 is available at this time, the following factors: "the strength of the plaintiffs' case; the risk, expense,
17 complexity, and likely duration of further litigation; the risk of maintaining class action status
18 throughout the trial; the amount offered in settlement; the extent of discovery completed and the
19 stage of the proceedings; the experience and views of counsel; the presence of a governmental
20 participant; and the reaction of the class members to the proposed settlement." *See In re Volkswagen*
21 *"Clean Diesel" Mktg., Sales Practices, and Prods. Liab. Litig.*, 895 F.3d 597, 610 n.18 (9th Cir.
22 2018) (quoting *Hanlon v. Chrysler Corp.*, 150 F.3d 1011, 1026 (9th Cir. 1998)).

23 The Court further finds that: (i) the Settlement has been negotiated at arm's length between
24 experienced attorneys familiar with the legal and factual issues of this case and was reached with
25 the assistance of the Ben Picker, Esq. of Stradley Ronon Stevens & Young LLP; and (ii) the
26 Settlement warrants Notice of its material terms to the Class Members for their consideration and
27 reaction. Therefore, the Court grants preliminary approval of the Settlement.

1 4. The Court conditionally certifies, for settlement purposes only, the following Classes¹:

2 **Nationwide Class**: All natural U.S. persons who are current or former employees or
3 contractors, including their dependents, of UKG customers, whose data was stored in the
4 KPC at the time of the December 2021 KPC Cyberattack and who were impacted by the
5 interruption of KPC applications resulting from the December 2021 KPC Cyberattack.

6
7 **California Subclass**: Consisting of all members of the Settlement Class who are also
8 California residents at the time of the December 2021 KPC Cyberattack; and

9
10 **Exfiltration Subclass**: Consisting of all members of the Nationwide Class who were sent
11 notice that their personal data was exfiltrated during the December 2021 KPC Cyberattack
12 and were offered credit monitoring services for themselves or on behalf of their dependents.

13 6. The Court finds that, for settlement purposes only, the requirements of 29 U.S.C. § 216,
14 Fed. R. Civ. Proc. 23(a), and Fed. R. Civ. Proc. 23(b)(3) are satisfied, with the exception of the
15 manageability requirement of Rule 23(b)(3), which the Court need not address for purposes of
16 settlement.

17 7. The Court appoints Plaintiffs William Muller, Antonio Knezevich, Adam Bente and Cindy
18 Villanueva as the Class Representative for settlement purposes.

19 8. The Court appoints Michael S. Morrison and Erin Lim of Alexander Morrison & Fehr
20 LLP; Dimitrios Korovilas and Jason Wucetich of Wucetich Korovilas LLP; Ronald A. Marron,
21 Alexis M. Wood, and Kas L. Gallucci of Law Offices of Ronald A. Marron; and Jonathan M. Lebe
22 and Zachary T. Gershman of Lebe Law, APLC as Class Counsel for settlement purposes.

23 9. The Court appoints Kroll Settlement Administration, LLC as the Settlement
24 Administrator.

26 ¹ Excluded from the Classes are UKG's officers, directors, and employees; any entity in which UKG
27 has a controlling interest; and the affiliates, legal representatives, attorneys, successors, heirs, and
28 assigns of UKG. Excluded also from the Settlement Class are members of the judiciary to whom
this case is assigned, their families and members of their staff. Also excluded from the Settlement
Class are non-natural persons.

1 10. The Court finds that the procedures for notifying the Class about the settlement as
 2 described in the Settlement Agreement and attached Class Notice, as well as the efforts described
 3 by Kroll, provide the best notice practicable under the circumstances and therefore meet the
 4 requirements of due process, and directs Kroll to proceed with them. The Parties may, by agreement,
 5 revise the notice in ways that are not material or that are otherwise appropriate.

6 11. Each Settlement Class Member will have seventy-five (75) days after the Notice Date as
 7 described in the Settlement Agreement to opt out, submit a dispute, or object to the Settlement, as
 8 described in the Settlement Agreement and the Class Notice.

9 12. In the event that the Settlement Agreement fails to become effective, is overturned on
 10 appeal, or does not become final for any reason, the Parties shall be restored to their respective
 11 positions in the Action as of the date of the signing of the Agreement, and no reference to the
 12 Settlement Classes, the Settlement Agreement, or any documents, communications, or negotiations
 13 related in any way thereto shall be made for any purpose.

14 13. The Court retains continuing and exclusive jurisdiction over the action to consider all
 15 further matters arising out of or connected with the Settlement, including the administration and
 16 enforcement of the Settlement Agreement.

17 14. The Court, pending final determination of whether the Settlement should be approved,
 18 stays all proceedings except those related to effectuating the Settlement.


19 15. The Court will conduct a Final Approval Hearing on ~~November 17~~, 2023, at
 20 10:00 a.m./~~p.m.~~, or as soon thereafter as the matter may be heard, to confirm the overall
 21 fairness of the settlement and to fix the amount of reasonable attorneys' fees and costs to Class
 22 Counsel and enhancement payments to the Class Representatives. The Final Approval Hearing may
 23 be continued without further notice to members of the Settlement Class. An implementation
 24 schedule is below:
